Commercial Driver License - TN.gov

CDL Learner's Permit To obtain a CDL Learner's Permit, you must take and pass the CDL general knowledge test and other necessary knowledge exams (Air Brake, Combination, Tanker, Multiple Trailer, Passenger, School Bus) at a Full-Service Driver Services Center.

Required Documents to Apply for a CDL - TN.gov

The spouse, parent/child, sibling, or grandparent of the CDL applicant needing to use a relative's address and domicile documents MUST hold a valid Tennessee Driver License or ID Only License. The CDL applicant will be required to present two (2) documents with a Tennessee residential address in the name of the immediate relative.

Entry-Level Driver Training (ELDT) - TN.gov

The Federal Motor Carrier Safety Administration's (FMCSA) Entry-Level Driver Training (ELDT) is the minimum Federal requirement for training that entry-level drivers must complete before being permitted to take certain Commercial Driver License (CDL) knowledge or road skills tests.

Commercial Driver License Citations - TN.gov

The State of Tennessee reporting requirement for commercial vehicle convictions is 5 days. According to Tennessee Law (Public Acts 2010, Chapter 1037) anyone holding a Commercial Driver License must report all traffic citations whether they are Non-CDL or CDL related. Renewing Your License - TN.gov

If you have a Class A, B or C Commercial Driver License (CDL), you are required to renew your license in-person at a Driver Services Center. CDL holders must also provide their current valid Medical Certification at the time of renewal.

Medical Certification Requirements - TN.gov

For more information about an expired medical certificate, contact the Commercial Driver License (CDL) MedCert Section at (615) 502-4179. Do not go a Driver Services Center until advised by the MedCert Section. Assurance that medical certification information is successfully posted to the driver's motor vehicle record.
