PICS "RESEARCH" - Pennsylvania Firearm Owners Association

The State of Pennsylvania will act as the point of contact for NICS checks for all firearms transactions. To request a NICS check for any firearm transaction you must contact the Pennsylvania State Police by dialing 1-888-xxx-xxxx (this number is for FFL's only).

It is far from instant. It can take as long, sometimes longer, than PICS even though PICS uses NICS for checks. Also, a denial can take months to get a reversal on. The NICS site advertizes 60-90+ day review for challenges. Where as PICS is usually reversed in less than 2 weeks.
